I, Mr. Alwyn D'souza, Proprietor of Alwyn D'souza & Co., Company Secretaries have been appointed as Scrutinizer by the Board of Directors of **Future Market Networks Limited** (the Company) for scrutinizing postal ballot voting including voting by electronic means in respect of the resolutions contained in the notice dated February 02, 2019 through postal ballot.

1. After the time fixed for closing of the e-voting ie, 5.00 p.m on Monday, March 11, 2019 the votes were unblocked at 5.15 P.M on the e-voting website of the National Securities Depository Limited, (<http://www.evoting.nsdl.com>) and a final electronic report was generated by me. The data generated was diligently scrutinized.
2. The physical postal ballots received till the time fixed for closing of the Postal Ballot ie, 5.00 p.m on Monday March 11, 2019 were diligently scrutinized and reconciled with the records maintained by the Company through their Registrar and Share Transfer Agents Link Intime India Private Limited and the authorisations lodged with the Company.
